Meg Backus noted her written report was included in the Board packet. Highlights of current issues include:

The NYS Historical Newspaper project is aging out of its current hardware and software. Staff have identified a possible vendor to take on the project and are exploring costs and scenarios for the projects future sustainability.

Advertising for the vacant Regional Services Librarian position and applicant interviews are anticipated to take place in the early part of the New Year.

The ARPA projects are wrapping up. The project's final report is due to the State in April.

An initiative of the American Library Association invites us to become partners in the movement against book bans. Organizations and individuals alike can join the campaign to fight censorship in their communities and their states. The Northern New York Library Network has signed on, as have many other library organizations in the state (and beyond).
