Motion 23/24 - - 10: Krista Briggs (Sarah Weisman) moved to approve the July 20, 2023 meeting minutes as distributed. Motion carried unanimously.

Financial Reports

State Report

Director's Report

Meg Backus noted her written report was included in the Board packet, and members discussed several items. Highlights included:

- New upgraded newspaper site went live August 23, 2023.
- Proposed resource sharing between the ESLN councils suggested by Meg was well-received. Councils will work together to aggregate a robust schedule of online webinars, collaborate

to design and educational series covering topics that bridge member skills, and create and support learning collaboratives state-wide.

- Fall Meeting is October 4, 2023 at the VIC, Paul Smith's, NY. The meeting is both online and in-person. Depending on registrations the meeting may be fully remote.
- PD grants awarded
 - o Marissa Caico, SUNY Oswego, \$1200, CLIR/DLF Forum, St Louis MO, Nov 13-16, 2023.
 - Chessie Monks-Kelly, Historic Saranac Lake, \$400, Moving Museum Collections Course, virtual, beginning Sep 4, 2023.
 - Mary Cabral, Clarkson University, \$877 for two events: UNYOC Annual Conference (Upstate New York and Ontario Chapter of the Medical Library Association), \$607, Oct 25-27 AND Imagining America: Radical Reckoning: Invoking the Elements for Collective Change, \$270, Oct 25-27. Both were awarded as the total was below the limit of \$1200/grant.
- Neighbor to N on US-11 is requesting permanent easement from NNYLN for a portion of their parking lot NNYLN has licensed to them since 2000. Use does not affect NNYLN activities. Consulting atty Andy Silver of Silver and Silver in Canton.
